
Most people would agree that we have seen a pandemic of fear and terror sweep across the entire world. It is well known that EMF radiation affects the blood and the Iron within it.



“–NA–MNPs (magnetic nano particles) Self-Assembly– DNA is considered as a core genetic biological molecule in living systems. Although DNA molecules are composed of simple units, different deoxynucleotide chains and flexible conformations can be achieved through precise design and organization, which can be programmed. In other words, this is the nature of DNA self-assembly. For example, Ma et al. introduced DNA-modified MNPs, Y-scaffolds, and DNA linkers into the framework of DNA hydrogels to construct magnetic controllable DNA hydrogels.”

Darpa are currently funding a number of projects to develop computer brain interfaces. Battelle Memorial Institute are working on Brain STORMS (Brain System to Transmit Or Receive Magnetoelectric Signals)

“The nanotransducer would use magnetoelectric nanoparticles to establish a bi-directional communication channel with the brain. Neurons in the brain operate through electrical signals. The magnetic core of the nanotransducers would convert the neural electrical signals into magnetic ones that would be sent through the skull to the helmet-based transceiver worn by the user. The helmet transceiver could also send magnetic signals back to the nanotransducers where they would be converted to electrical impulses capable of being processed by the neurons, enabling two-way communication to and from the brain.” – [Magnetism Plays Key Roles in DARPA Research to Develop Brain-Machine Interface without Surgery](#)

Another Darpa funded CBI project called MOANA (Magnetic, Optical, and Acoustic Neural Access) is led by Rice University.

“In Phase 1, the team identified a genetically targeted magnetic stimulation technology that can achieve cell-type specific stimulation with a spatial resolution defined by the distribution of genetically modified cells (< 1mm) and with a temporal resolution approaching 10 ms. Among other accomplishments in Phase 1, were efforts in write technology that achieved targeted and non-invasive delivery of viruses in mice, demonstrating fast magnetic stimulation in mammalian cells; also in viral delivery using magnetic Iron oxide nanocrystal clusters of core/shell with high magnetic heating efficiency and magnetothermal multiplexing

In Phase 2, the team aims to advance its work further toward the goal of reaching demonstration in humans in Phase 3. Among the goals for Phase 3 are to accomplish non-surgical reads, writes with magnetogenetics, and to demonstrate closed-loop brain-to-brain MOANA link in humans.” – [Magnetism Plays Key Roles in DARPA Research to Develop Brain-Machine Interface without Surgery](#)

There is also considerable evidence that the bodies of people who have not received the injections are also showing magnetic anomalies. The measurable electric field that the body produces is incredibly small and the magnetic field even smaller. An energetic change in the bio-field could be a more plausible explanation, caused by technological developments that are not widely understood. Nano scale particulates found in the environment that have not been cleared from the body due to poor liver function is worth considering as a possible cause. The changes to the delicate electromagnetic system of the earth caused by the huge increase in technological devices on earth and more importantly in the upper atmosphere should also not be underestimated. It is also quite possible that some or even all of the non-injected people showing magnetic like properties have always been magnetic but have only just found out due to testing themselves because of the ‘magnet challenge’ craze. It is not yet possible to know exactly what is causing this phenomenon. At the present time however, there is enough evidence to suggest that it could relate to some kind of [self-assembling nano technology](#) or to a technology that is not discussed in published papers that somehow effects the [bio-field](#) given that:

[Magnetogenetics and Magnetofection](#)

"If scientists could give living cells magnetic properties, they could perhaps manipulate cellular activities with external magnetic fields... The new area of magnetogenetics seeks to use genetically encoded proteins that are sensitive to magnetic fields to study and manipulate cells. Many previous approaches have featured a natural Iron-storage protein called ferritin, which can self-assemble into a "cage" that holds as many as 4,500 Iron atoms. But even with this large Iron-storage capacity, ferritin cages in cells generate magnetic forces that are millions of times too small for practical applications. To drastically increase the amount of Iron that a protein assembly can store, Bianxiao Cui and colleagues wanted to combine the Iron-binding ability of ferritin with the self-assembly properties of another protein, called Inkabox-PAK4cat, that can form huge, spindle-shaped crystals inside cells. The researchers wondered if they could line the hollow interiors of the crystals with

ferritin proteins to store larger amounts of Iron that would generate substantial magnetic forces.” – [Engineered protein crystals make cells magnetic](#)

Like optogenetics (see [Covid 19 Injection](#)) magnetogenetics uses a combination of genetic manipulation and external stimuli to achieve control of biological and neuronal processes.

“Researchers in the United States have developed a new method for controlling the brain circuits associated with complex animal behaviours, using genetic engineering to create a magnetised protein that activates specific groups of nerve cells from a distance...

...nerve cell proteins which are activated by heat and mechanical pressure can be genetically engineered so that they become sensitive to radio waves and magnetic fields, by attaching them to an Iron-storing protein called ferritin, or to inorganic paramagnetic particles...

...they used genetic engineering to fuse the protein to the paramagnetic region of ferritin, together with short DNA sequences that signal cells to transport proteins to the nerve cell membrane and insert them into it...

...the researchers **inserted the Magneto DNA sequence into the genome of a virus**, together with the gene encoding green fluorescent protein, and regulatory DNA sequences that cause the construct to be expressed only in specified types of neurons. They then injected the virus into the brains of mice...

In one final experiment, the researchers injected Magneto into the striatum of freely behaving mice, a deep brain structure containing dopamine-producing neurons that are involved in reward and motivation, and then placed the animals into an apparatus split into magnetised a non-magnetised sections. **Mice expressing Magneto spent far more time in the magnetised areas than mice that did not*****, because activation of the protein caused the striatal neurons expressing it to release dopamine, so that the mice found being in those areas rewarding. This shows that Magneto can remotely control the firing of neurons deep within the brain, and also control complex behaviours.” – [The Guardian Genetically engineered ‘Magneto’ protein remotely controls brain and behaviour](#)



“The use of superparamagnetic Iron oxide nanoparticles (SPIONs) to deliver genes via magnetofection shows promise in improving the efficiency of gene delivery both in vitro and in vivo. In particular, the duration for gene transfection especially for in vitro application can be significantly reduced by magnetofection compared to the time required to achieve high gene transfection with standard protocols. "In this work, we have shown remote-controlled mechanical **dissociation** of short DNA duplexes (18–60 bp) under the influence of nonheating low-frequency alternating magnetic fields using individual 11 nm magnetic nanoparticles. The developed technique allows (1) simultaneous manipulation of millions of individual DNA molecules and (2) evaluation of energies of intermolecular interactions in short DNA duplexes or in other molecules. Finally, we have shown that DNA duplexes **dissociation is mediated by mechanical stress and produced by the movement of magnetic nanoparticles in magnetic fields**, but not by local overheating. 

It is worth considering all possibilities regarding the potential technology that could be in the injections and in nano scale particulate environmental pollutants.

Material Occultism

“By means of this capacity – and this is precisely the ideal of British secret societies – certain social forms at present basic within the industrial system shall be set up on entirely different foundations. Every knowing member of these secret circles is aware that, solely by means of certain capacities that are still latent but evolving in man, and with the help of the law of syntonic oscillations, machines and mechanical constructions and other things can be set in motion. A small indication is to be found in what I connected with the person of Stader* in my Mystery Dramas.

These things are at present in process of development. They are guarded secrets within those secret circles in the field of material occultism. *It should be noted that the idea shown by Stader machine was likely based upon a form of material occultism. However due to the social and technological developments that took place in the 20th century it is arguably no longer a suitable avenue of development, if the objective of such developments is to help humanity at large.

John Worrell Keely's earlier motors used the force of sympathetic vibration, they were able to amplify moral impulses that he was able to generate in his etheric body – setting the machines in motion. This technology can be referred to as (moral) mechanical occultism. Keely abandoned this earlier technology because he was the only one who could set the machines in motion. For this reason he abandoned this first moral kind of technology and concentrated on technology using a force opposite to the one he had hitherto employed. He called this new force “negative attractive force”. It was also based upon the principle of sympathetic vibration, it was related to, but not the same as, modern electrical engineering with its use of alternating current. It was a more advanced form of electrical engineering. It can be referred to as material occultism.

We should not rule out the possibility that those brotherhoods who are well aware of both mechanical occultism and material occultism, have developed material occultism to the point that it could be used to further their aims of power and control. Could a form of this technology be responsible for the affects we are seeing and could it be used in the future to harness the energy within our bodies for data processing and the like? The seeds of doing this using overt science has already been [planted in the minds of many](#).

It is often said that we are playing checkers while the representatives of the adversarial powers are playing three-dimensional chess. It is much worse than that, we are playing checkers and they are working with understanding of the [14 spiritual levels that are shown on](#)

[the diagrams page](#) and their inverted counterparts. We cannot afford to stay ignorant of spiritual matters any longer! Looking at scientific papers to explain the technological transformation of the human being only gives us part explanation as to what exactly is taking place. As I hope the reader is starting to glimpse, there are non-physical implications that can not be explained with the physically based sciences alone. Aspects of the technology we are seeing have quite specific spiritual affects on human beings. But Ahriman-Sorat will incorporate into electronics another kind of component that is indeed the bearer of intelligence: the human being himself. As people transform their bodies with tranhumanist technology and ultimately connect themselves to the internet using computer brain interfaces their soul life will become bound to the internet. 

Electronics, in particular digital electronics, artificial intelligence has been placed in the service of the Ahrimanic double. The whole atmospheric sphere of our planet is saturated with the harsh square-wave radiation of digital radio, radar, television and Wi-Fi transmitters, which impress their vibration-patterns, by induction, onto the human nervous system, blanking out perception of Christ. Meanwhile the binary electronic operations of the individual computers, Internet and the World Wide Web draw living human souls down into the subnatural sphere of the Sorat, the great Sun Demon. If the development of technology had followed its normal path, none of this would have existed. But the occult brotherhoods have imposed their deviant technology on us. Steiner said that by means of this immensely evil technology, the souls of the dead would be forcibly introduced into artificially intelligent machines. Today’s regular gamers, whose souls are wed to their avatars during life*, will not experience a normal death. When the body dies, the soul will remain in the Earth-realm, in the electromagnetic fields, bound to the avatar in the data banks of the World Wide Web.” – [Paul Emberson Supersensible Researcher, 50 Years from Now \(written in 2009\)](#)

**Here Paul is not implying that this will be the fate of anyone who plays computer games, he is referring to someone who is materialistically minded and who feels that their online Persona or Avatar to be more representative and of who they are than the person they are in the real world.

It is all too easy to separate the physical and spiritual in our minds when in reality there is no such division, the spiritual affects the physical and what we do in the physical world affects the spiritual. The spiritual essence of the human being is arguably much more valuable than someones body. Why just kill people if you can instead do so in such a way that furthers your dark and nefarious aims? The physical benefits obtained by certain parties in relation to the manipulation of society to amass wealth and power is clear to see, is it so hard to believe that people with such a mind set would not also wish to manipulate people spiritually after they have died for those and other objectives?

“So now let us assume that here is the realm of one of those brotherhoods [small circle, green]. This brotherhood is spreading the doctrine of materialism and ensuring that these human beings most probably think in a purely materialistic way. By this means the brotherhood succeeds in generating souls for itself that remain in the earthly sphere after death. They become the spiritual clientele, of this lodge [orange]. In other words, by this means dead souls have been created who do not go out off the earthly sphere but remain with the earth. By making the right arrangements they can be held within the lodge. So in this way lodges have been created which contain the living but also the dead, the dead who have become related to the earthly forces.



Matters are then directed by these people here who hold sessions or by means of arranging meetings like the spiritualist seances of the second half of the nineteenth century about which I have frequently spoken. It can then happen – and please take note of this – that what goes on here in the sessions is directed by the lodge with the help of the dead. But it is the intention of the masters in those lodges that the people must not know that they are dealing with the dead, for they are meant to believe that what they are dealing with are simply higher forces of nature. The intention is to show people that these are higher forces of nature, psychism and so on, merely higher forces of nature. The concept of the soul as such is taken away and the people are told: ‘Just as there is electricity, and magnetism, so are there similar higher forces.’ Those who lead the lodge hide the fact that these things are coming from souls. So those other, innocuous souls gradually become dependent, psychologically dependent, on the lodge without knowing what they are dependent on or where that which is directing them is coming from.

The only defence against these things is knowing about them. If you know about them you are protected. If you know about them in that you really regard them as true, that you really believe them to be like this, then you are protected. But you must not be idle about acquiring real knowledge about these things. For the present, however, it can still be said that it is not yet absolutely too late regarding this. These things can only be clarified gradually and I can only slowly gather together the various elements by which you can be given full clarity. – Rudolf Steiner Secret Brotherhoods and the Mystery of the Human Double P. 137

The following shines some light as to why an outright materialist can become Earth bound after death and as to what effect love for the sub material world of artificial reality might have.

“At the stage the world has now reached in human evolution we must acquire spiritual concepts if we want to detach from ourselves something we would otherwise carry within us only as though asleep. People find these spiritual concepts awkward because they have to make some effort, more effort than would be necessary for ordinary concepts. But if they acquire them, then, after death these concepts develop tremendous power, and it is this power alone that gives us the ability to recognize and comprehend the spiritual world. This is exceedingly important. People today feel uncomfortable if they have to acquire spiritual concepts. They like going to meetings where they are shown lantern slides or similar things and therefore do not have to

think in a supersensible way; they like to see things in front of them, or at least hear lectures that tell them only about what they anyway always have before their eyes. People today shy away from making an effort to ascend to concepts that are more difficult here because they have no outer object since their objects are the facts that relate to the supersensible world. Over there, however, these concepts are the forces which actually bring the reality of the world to us.

Through spiritual ideas and concepts we gain the wisdom we need in order to have light over there where otherwise everything will be in darkness. What we attain here in the way of wisdom is light, spiritual light, over there. Wisdom is spiritual light. We need wisdom in order not to find ourselves in darkness over there. Not to acquire spiritual concepts is the best way of having no light over there. And when one has no light one moves away again from the sphere into which one ought to be casting light; one drifts back to earth and wanders about there as a focus of destruction. At most one might be used from time to time by a black magician in order to provide inspiration for certain quite specific functions, but also for destructive activities on the earth.

Wisdom, then, is something we need so that we can have light after death. But there is something else we need after death as well. The ability to detach the beings of the spiritual world in order to be able to confront them is not the only thing we need, for we also have to have the faculty of love. If we did not have this we would be unable to develop a proper relationship with the beings whom wisdom enables us to perceive. We need the faculty of love. However, the love engendered here on the earth is for the most part dependent on our physical body. This love is a feeling and it depends on the rhythm of breathing here in the physical world. It is not the kind of love that we can take with us into the spiritual world. It would be a complete illusion to believe that we can take this love over with us into the spiritual world, especially the kind of love we develop here at this particular time. What we do take over into the spiritual world is all the power of the love we acquire here in the physical world through perceiving this world with our senses, through living with this physical world.

This love is fired in us by the understanding we can develop for the physical world as we live here in it. If we take into our feeling life specifically those experiences we can have in viewing the world by means of modern science, this leads to love developing for when we are over on the other side.

Love, however, is something that can be either high or low depending on the realm in which it unfolds. If you pass through the gate of death and then have to remain in the earth realm as a focus of destruction, well, this is also due to having developed great love. The fact that you have to remain like this is a consequence of your having been bound up with purely naturalistic concepts, but then you employ this love for works of destruction; you love the work of destruction and are condemned to observe yourself loving the work of destruction.


Love, then, is noble if you can rise up to higher worlds and love what you gain through spiritual concepts. We must on no account forget this: Love is lowly when it works in a lowly sphere, and it is noble and high and spiritual when it works in a higher, a spiritual sphere. This is the essential point to be remembered. If you remain unaware of this you will be unable to discern things in the right way.” – Rudolf Steiner *Secret Brotherhoods and the Mystery of the Human Double* P. 53

The technology that is being injected into people is not the technology that will realise the next phase of human beings' evolution, it is the tool of our enslavement, the dark counterpart to a moral technology that must now be developed, a technology which will in a certain way connect with human beings but in such a way that it will leave them free to develop organs of spiritual perception, the intended next phase of our evolution. Please at least consider that we are not just seeing an attempt at the physical enslavement of the human being but also the spiritual enslavement, the spiritual enslavement following the physical enslavement which is designed in such a way as to systematically reduce someones 'I' constitution, make them complete materialists though belief systems and medical devices and then bind their souls and intelligence to sub earthy virtual worlds! This does not have to manifest everywhere, we can and must create an alternative.

First, we have to understand that the heart is not mechanical but takes its orientation from the human being. Then people will also find the basic principles for external machines, making them such that they take their orientation from the human being. But in a science which has so much taken the easy way that the heart is described as if the human being had just a pump there in the blood circulation, in such a science people will feel no compunction to make machines where the human being has to take his orientation from the machine. **All the problems in our social situation are due to this wrong view that is taken in science.** And so one really has to understand that a proper way of thinking must first of all come upon people, for only then will it be possible to begin a proper social life. For as long as people think the heart is a pump, they will also not be able to relate to outer life in the right way. **It is only when people know that the invisible human being is greater than his heart, that it is he who moves the heart, that they will also design their machines to be in accord with human nature.** – Rudolf Steiner From Mammoths to Mediums, June 6 , 1923, GA 350

"In our time there are certain changes taking place in the heart, by which gradually a fifth chamber will develop. In this fifth chamber man will have a new organ which will allow him to control life forces in a different way than is possible at the moment." – [Spiritual Science and Medicine, Lecture VIII, March 27, 1920, GA 312](#)

Steiner spoke about artificial intelligence in 1917. He said that if this was to come about in a healthy way we would need to develop technology in which the cosmic forces of Pisces and Virgo act in co-operation.

–THE FALL OF THE SPIRITS OF DARKNESS–

"During the last three or four centuries we have developed a magnificent natural science and a far-reaching technology, based on the most widely-distributed material to be found on earth. We have learnt to make out of Iron nearly all the most essential and important things produced by mankind in a materialistic age.
